### FOR THE SAKE OF ART 2014 | WEARABLE ART COMPETITION

Houston, Texas June 2, 2014: Houston, Texas. On Saturday, June 14, 2014, the University Museum will host its third biannual wearable art competition and fundraiser. Chaired this year by Cheryl Elliott Thornton and Peter B. Thornton, the gala event is a unique and exciting tribute to both fine art and high fashion. The originality of the completion serves to not only highlight works from the museum's stellar permanent collections of African American, African and American art, but also creates an opportunity for some of the region's most creative artists and designers to have their work judged and critiqued by fashion industry experts while being viewed by an audience of art collectors and fashionistas alike. Fifteen semi-finalists have selected a work of art from the collections as inspiration for their wearable art creations. The designs will be presented runway style at the gala, followed by conversations with the judges to determine the grand prizewinners. Judges for FSOA 2014 are fashion icon, philanthropist, and Best Dressed Hall of Fame awardee Lora Clemmons; Dallas textile and fashion designer Elizabeth Anyaa serves an international clientele; and award winning designer Cesar Galindo, a Houston native currently based in New York. Moderators for the evening are Joy Sewing, fashion writer for the Houston Chronicle and Phillip Collins, independent curator from Dallas and Director of the Menenmse Foundation. Recognized at the event will be the Honorary Chairs, Mrs. John (Hazel) Biggers and Mrs. John (Drucie) Chase, renowned arts advocates and cultural icons of the Houston community.

In addition to the runway competition, a silent auction featuring the art of some of Houston's most talented and exciting contemporary artists will be featured. On view will also be the exhibition **Playing By Dragon Rules** focusing on the art of Abidemi Olowonira and Gregory Michael Carter, two artists who have worked extensively in China and Japan respectively. Music for the festive evening will be provided by the Horace Alexander Young Trio.

#### **Judges**

**Elizabeth Anyaa's** textile designs have been described as ethereal, sensual and contemporary and her international clientele regard her uniquely designed garments and accessories as works of art. Trained in Helsinki, Finland, Ms Anyaa, originally from Ghana and Sierra Leone, has been featured in WWD, the Dallas Morning News, PaperCity Dallas, FD Luxe, D Home, and Modern Luxury. Her designs and accessories are currently shown at Neiman Marcus Beverly Hills

Lora Clemmons has long been a respected and devoted contributor to the betterment of the Houston community. Recognized for her fashion style and consummate taste, Lora was inducted into the Houston Chronicle's Best Dressed Hall of Fame in 2001. Currently she serves on the Advisory Board of The Ensemble Theater and Board of Trustees for The Houston Ballet. Additionally, she has served on the Board of Governors of The Houston Grand Opera and the Board of Trustees for the Houston Symphony and Society for The Performing Arts. As an attorney, she brings her legal expertise to all of her non-profit volunteerism

Cesar Galindo has served as a judge for the competition For the Sake of Art since its inception in 2011. He brings to his work with the young designers in the competition both a seasoned and experienced presence as a designer and a supportive and encouraging energy as a mentor. Both of these qualities were evident in Cesar's participation in Lifestyle TV's The Fashion Show with Isaac Mizrahi, where he was selected as a finalist in that competition. Cesar achieved notoriety when his washed silk kimono dress made the cover of Elle Magazine, July 1993, on supermodel Karen Mulder. Over the next two decades, the brand CESAR GALINDO has developed in distribution domestically and internationally at select retailers.

#### **Competition Coordinator and Advisor**

Competition coordinator **Andrea Bonner** is the owner of *Style On Demand*, a Houston based, fashion consulting and styling firm. She is the immediate past Regional Director for The Fashion Group International of Houston, Inc. and is an adjunct professor for the Lifestyle Arts and Design Careers Department of Houston Community College. She works as a volunteer for Dress For Success Houston, Star of Hope and Aids Foundation Houston. Hailed in 2004 as the Houston Chronicle's "Ultimate Fashion Designer", Toni is currently providing unique professional opportunities and training to emerging designers through her **Houston Incubator Project.** Known for her couture and avant garde designs, Whitaker is the designer of choice for many of Houston's leading fashion icons, including several repeat honorees of the Houston Chronicle's Best Dressed List.
